- The 2024/2025 budget was passed by a majority in Full Council (23 For: 8 Against).
 - A motion by the Conservatives to freeze member allowances and use the funds to retain free Sunday parking was defeated by the administration.
- CDC's Council tax will increase by £5 for a Band D property (£153.93)
- Green Bin licences will increase to £64 (from £57)
- Car parking charges will be increased
- Free parking on Sundays in CDC car parks will be phased out
- Residents are invited to give their views on updates to Cotswold District Council's adopted Local Plan (2011 2031) to make it 'Green to the Core'. **Consultation will close on the 7th of April.**
 - It is important that residents take part in the consultation to ensure that the Council is made aware of any concerns or aspirations that residents have regarding future development.

THE PLANNING ENFORCEMENT TEAM
