20201028/001	<p>Public questions</p> <ul style="list-style-type: none"> • Thanks were passed on to the PC for cleaning the street around the conker tree. • It was noted that no sign has been erected yet. A request for an update on parking was received. • Concerns were raised in respect to exiting Millbrook Ley due to poor visibility caused by overgrowth of vegetation blocking the view out of the road. Trees in the verge on the left have been cut back but not the right side. It is believed that this side is the responsibility of highways. • Village hall - The notice board's backboard is flapping and there is no key for it. A member of the public indicated that Alan Beale from the VH has offered to add a toggle to hold it closed. Tony agreed for the temporary repair until a new notice board is sourced. • A thank you to Julian Thomas was requested for clearing the area next to the bench by the bus shelter at the edge of the Village Green.

20201028/5	Emma declared an interest in the flood plan – Clerk agrees her participation is essential in the report.	
20201028/6	<p>Car Park Charges to rise - Cllr Beale reported that the District Council is to raise charges in its car parks. They have taken this decision due to the increasing financial demands through Covid. The leisure centres and Corinium Museum which have been open and operating with good attendance, all require financial support from the Council to continue with their service. The District Council is prioritising support to these services for the physical and mental health of the public.</p> <p>Refuse Collection - All councillors agreed that the rubbish collection service was running well after a few previous hiccups.</p> <p>Highways - It was confirmed that works to 'Lucy's trees' and verge have been done. Various discussions were held in respect to verges and works required throughout the village; however ownership of the different areas were disputed. It was noted that some areas that have always been maintained by Highways were now not being kept under control.</p> <p>Car Park area in Wheat Close- It was understood that, although Highways had the budget to progress with the car parking area on the old garage land, the work did not go ahead as it was wrongly</p>	Cllr Beale to progress with

	<p>believed by CDC that the land belonged to Bromford Housing. It now appears that the verges are still owned by CDC and were not transferred in the housing stock lot to Fosseyway Housing (now Bromford) in 1997.</p> <p>Cllr Beale stated that CDC would be willing to hand over the verges to the PC if they wished to take over responsibility. The Council was not in favour of this, particularly if the land had not been transformed into parking in advance.</p> <p>Cllr Beale confirmed that a representative of Bromford Housing agreed that parking could continue by residents on the old garage land as Bromford had not yet decided what to do with this and many of their other small parcels of land. A decision will be made in the near future.</p> <p>Trees - Cllr Beale also confirmed that the CDC tree officer has agreed to reduce the horse chestnut crown by 40% and will remove deadwood from the adjacent Ash tree, which is not suffering from dieback and quite healthy. Works will be done later during winter months.</p> <p>Bridge closure, Evenlode Road - Signs appear to have been removed and Cllr Beale believes it is safe to use, however it will be closed again this weekend for investigative work. Cllr Ashton confirmed that Railway network will be making a trial hole to test the strength of the bridge. Further works will be continued in January 21.</p> <p>Cllr Beale confirmed it would be good to get Cllr Stowe involved for all the County works required.</p> <p>Cllr Julian Beale left the meeting with the members of public at 20:49.</p>	<p>Bromford and the Estates office at CDC</p> <p>Clerk to chase</p>

20201028/8	<p>The Chairman welcomed Debbie to the council. Debbie introduced herself and confirmed handover with Dom went well; she reported that a new laptop and printer would be required. It was unanimously resolved to budget £500 for these purchases.</p> <p>Clerk would like to change emails from live.co to maybe Outlook/Google & also advised that all the councillors should have a personal council email for council business.</p> <p>Cllr Thorley volunteered to do first check of defibrillator – clerk to send check list. The councillors will take it in turns to do the checks. 	<p>b) As above Chairman to revisit and hold a separate meeting for traffic calming in the village.</p> <p>c) Water run-off in several areas of the village is a concern, notably on the hill down to the Ford. Concerns were raised for winter when it can become icy. Cllr Neil confirmed he has reported blocked drains repeatedly. Cllr Ashton has mentioned the issue to Harry Roberts. PC to write to Highways. Cllr Beale proposed a meeting for members to meet with Rhodri Grey on site for all Highway issues. 20201028/10	<p>Flood Plan – Cllr Ashton confirmed a meeting was had with Lawrence King from CDC and his first plan was found to be unworkable.</p> <ul style="list-style-type: none"> • The original plan was found to be unsatisfactory, as not only would the landowner be allowing works on their land, but would also be left responsible for future maintenance and the liability for the flood defence. A revised plan appears to be well advanced, however Cllr Beale to find out what Mr King’s latest plan is and to confirm CDC will retain liability for flood defence with current owners retaining ownership of their land without liability. Cllr Ashton queried what was happening on the other side of the flood plain – Cllr Leonard to speak with Paul Teague. • The second issue with flooding is water run-off from Broadwell Hill causing flooding at the bottom of the hill. Cllr Ashton spoke with Harry Roberts and she reported back that the grips down the hill were not of a standard size with the gullies running down the left side of the hill not working. The works team on site had to use spades to try and clear out the area making it a longer process. Last Friday a jetter was on site but found pipes jammed full of roots therefore another works request will be submitted to finish off the clearance. It was agreed that this should be done annually but has not been done for a long time which is having an impact on flooding. • The third issue was where the Splash narrows - Cllr Thorley confirmed that the splash blocks up with silt, sticks and stone dams created from a tumble down wall by children.
